





Legislating gender

U.S. Rep. Mary Miller wants to define male and female in federal law

A member of Congress who represents portions of Sangamon County is sponsoring legislation to define, in federal law, what is a male and a female.

The move by U.S. Rep. Mary Miller, R-Illinois, stirred consternation among LGBTQ advocates and cheers from those skeptical of the concept of gender fluidity.

Miller proposed the Defining Male and Female Act two days before the Biden administration's new Title IX regulations took effect. Title IX is a 52-year-old law creating educational opportunities for women. The new regulations broaden the law to prohibit discrimination based on gender identity.

"Since Joe Biden and Kamala Harris took office, they have obliterated Title IX, allowing confused and predatory men into women's sports and restrooms," Miller said in a prepared statement. "The Defining Male and Female Act would provide clear legal definitions so that neither the Biden administration nor any future administration can redefine Title IX. We must protect biological women and girls' safety and opportunities, and I urge the House to act swiftly in passing this bill to recognize the fundamental differences between men and women."

Miller's communications director did not respond to multiple emails and phone messages seeking further information on the legislation.

Miller is a member of the Freedom Caucus, which is made up of Republican members of the U.S. House of Representatives considered to be part of the MAGA movement and loyalists to former President Donald Trump. In 2022, the freshman congresswoman easily defeated five-term incumbent U.S. Rep. Rodney Davis in a primary race that pitted the two incumbents against each other following

redistricting. Trump endorsed her at a rally held in Adams County just three days prior to the election.

Her husband, Chris Miller, serves in the Illinois House of Representatives and his Statehouse district largely overlaps with the eastern portion of his wife's congressional district. Rep. Chris Miller serves as chair of the Illinois Freedom Caucus, which held a July 13, 2023, event in Springfield to protest what they claimed were biological males using the women's locker rooms at the Kerasotes YMCA ("Transgender turmoil," July 27, 2023).

The bill defines a female as "an individual who naturally has, had, will have, or

would have, but for a developmental or genetic anomaly or historical accident, the reproductive system that at some point produces, transports, and utilizes eggs for fertilization," and a male is an "individual who naturally has, had, will have, or would have, but for a developmental or genetic anomaly or historical accident, the reproductive system that at some point produces, transports, and utilizes sperm for fertilization."

The language of the bill appears to have been drawn from model legislation pushed by the Heritage Foundation, a conservative Washington-based think tank.

Tennessee, Kansas and Montana have passed similar legislation at the state level. But in June, a Montana judge ruled the legislation in that state was not constitutional because the description of the law did not clearly state its purpose.

"The title does not give general notice of the character of the legislation in a way that guards against deceptive or misleading titles," Montana District Judge Shane Vannatta wrote.

Vannatta did not address discrimination arguments; he found that the bill's title did not explain whether the word "sex" referred to sexual intercourse or gender and did not indicate that the words "female" and "male" would be defined in the body of the bill.

The Kansas and Tennessee laws also face

legal challenges.

Brian Johnson, chief executive officer of the gay rights advocacy organization Equality Illinois, referred to Miller's measure as "hateful."

"It appears that what Congresswoman Miller is trying to do flies in the face of what professional doctors, medical providers, psychiatrists and, honestly, millennia of human experience demonstrate, which is gender is more dynamic and more fluid than the standard binary," Johnson said.

"At a time when people don't have access to enough adequate and affirming health care, when we see rapid and rising inequality in America, when we see deep distress for the institutions that previously served as the bedrock of America, the fact that Congresswoman Miller is ignoring meeting the needs of her constituents and Illinoisans in those areas so she can fight a culture war is deeply disappointing," he said.

But others found Miller's actions encouraging.

Matthew Eppinette, executive director of the Center for Bioethics & Human Dignity at Trinity Evangelical Divinity School in Deerfield, said there is a need to better define gender.

"Over the last five, six, seven years, we've seen questions arise. And I suppose it's understandable that our elected officials would want to try and bring some clarity," Eppinette said. "I do think that some people struggle with their identity in a whole variety of ways. And I think as these struggles have become more well-known through things like social media, there are people who have sought answers for themselves. I don't think that gender is fluid. I think that we are born either male or female."

Johnson, with Equality Illinois, said, "I think when this type of legislation is presented by someone who has such a strong track record of vitriol, of attacking parts of the American society that are crucial parts of our country (and) who has said so many hateful things, it is hard for me to see it as anything other than self-serving and hateful."

He added he does not anticipate the measure becoming law.

"I would be surprised if this moved forward in any meaningful way," Johnson said. "But who knows?" \Box

As of Aug. 6, the city of Boston, Massachusetts, has had eight homicides this year. Springfield, Illinois, has had seven, as of Aug. 9. In all last year there were five homicides in Springfield. Four of this year's victims died of multiple gunshot wounds in daylight hours, and three of these were young men -16, 17, 23. The grim statistics do not include the senseless death of Sonya Massey, who was killed by a sheriff's deputy outside of Springfield, and whose case deserves our focus now. County Board blocks referendum

Vote falls along party lines, differing legal opinions cited

More than 200 people clapped, cheered and yelled their support at the Aug. 13 Sangamon County Board meeting for changes at the Sheriff's Department beyond the resignation of Sheriff Jack Campbell in the wake of the shooting death of Sonya Massey.

But one of those suggested changes, a binding referendum on the Nov. 5 ballot to establish the ability of voters to oust any future sheriff, failed to move forward after the board voted 6-20, with all Republicans voting against and all Democrats voting in favor.

"I'm disappointed but not surprised," Breonna Roberts, a Springfield resident who supports establishing recall for sheriffs, said after the vote. "Clearly, we need to reassess who we have in positions of power."

At least 17 of the more than 30 speakers calling for more transparency, better training and a more thorough vetting process in the hiring of sheriff's deputies during the 3½ hours of public comments on the issue specifically backed a recall option.

The racially diverse speakers said they want to know why Sean Grayson – the 30-year-old, white former deputy charged with first-degree murder in the July 6 death of Massey, 36, a Black single mother of two – was hired despite a questionable employment history, two DUI convictions and a finding of severe misconduct when he served in the U.S. Army.

Before Campbell, 60, the Republican who hired Grayson in 2023, announced his resigna-

tion on Aug. 9, he said calls for his resignation were "nothing more than political maneuvering."

Republicans, who hold a supermajority on the board, didn't technically vote on the merits of holding a binding referendum. Instead, the progress of Democratic board member Sam Cahnman's proposal was halted on a technicality.

County Board Chair Andy Van Meter, a Springfield Republican, ruled that Cahnman's motion to amend his original resolution was out of order. The 6-20 vote upheld Van Meter's decision.

Cahnman originally proposed an advisory referendum asking voters whether Campbell should resign. Cahnman introduced that resolution before Campbell announced he would retire, effective Aug. 31.

Because an advisory referendum on Campbell would be moot, Cahnman on Aug. 13 tried to amend his original resolution so voters would be asked in a binding referendum to establish the possibility of recall for future Sangamon County sheriffs in recall elections.

However, Van Meter said legal advice from the State's Attorney's Office indicated Cahnman's proposed amendment was substantially different from the original resolution and could prompt a legal challenge if it were voted on as an amendment. As a result, Van Meter indicated Cahnman would need to introduce the proposal as a separate resolution. The problem for Cahnman is that the County Board would need to vote by Aug. 19 to meet a deadline for including the question on the November general election ballot.

The morning after the board meeting, Cahnman asked Van Meter and the rest of the 29-member County Board in an email to call a special County Board meeting on Aug. 19 to vote on putting a binding referendum on the November ballot calling for a recall process for future sheriffs. Cahnman, a lawyer, said he disagreed with the legal advice Van Meter received.

It's uncertain whether Cahnman's effort will succeed, because county code requires 10 board members to agree to schedule a special meeting. If the other seven Democrats on the board backed Cahnman, support from at least two Republicans would be required.

If he isn't able to get a binding referendum on the November ballot, Cahnman said he would attempt to get the measure on the ballot during the next election in April 2025.

Further complicating the issue is that Illinois State Board of Elections spokesperson Matt Dietrich told *Illinois Times* that state law may allow municipalities to establish the option of recall election, but county governments do not have that power for county elected officials.

Cahnman disagreed, saying a 2016 Illinois Appellate Court ruling makes clear that counties do have the power to establish a recall process for sheriffs and other countrywide officials.

Another Democratic county board member, Marc Ayers, said board member Gina Lathan of District 22 will introduce a resolution calling for an independent investigation of how and why Grayson was hired and how the hiring process can be improved and made more transparent to the public. He said the training of deputies and other sheriff's department employees can be improved to avoid the deaths of more people such as Sonya Massey.

"It's calling for lots of things to happen internally and externally in the sheriff's department," Ayers said, noting that the resolution will be considered first by the board's Jail Committee when it meets at noon Aug. 20 in the Sangamon South auditorium at 300 S. Ninth St. in Springfield.

Ayers, who isn't a lawyer, said he didn't agree with Van Meter's decision to rule a vote on Cahnman's amendment out of order.

"The people came here to see action, and we took action tonight, and unfortunately it was voted down by the majority on the board," Ayers said.

He said Republicans are scared.

"They're being told not to vote that way," Ayers said. "They're worried about politics. And they're worried that they don't have permission from their political leaders to even have an opinion on this matter, when this is the people's house. (The public) came here to seek action, and we failed them once again."





Judge orders Stateville prison to close by Sept. 30

A federal judge is ordering Gov. JB Pritzker's administration to move the vast majority of those incarcerated at Stateville Correctional Center near Joliet out of the aging prison by the end of September, citing health and safety concerns posed by the facility.

The Illinois Department of Corrections had previously stated its intention to close Stateville as early as September as part of a larger plan to rebuild it along with another prison. U.S. District Judge Andrea Wood's edict puts a Sept. 30 deadline on those efforts.

The judge's order, filed Aug. 9, is the latest in an 11-year-old legal battle over dirty and dangerous conditions at Stateville. While settlement talks have been ongoing since 2015, Pritzker in March announced a plan to rebuild Stateville, along with closing and rebuilding Logan Correctional Center in Lincoln. The decision was sparked by a state-commissioned report published last year identified them – along with Pontiac Correctional Center – as nearly "inoperable."

But in June, 51-year-old Michael Broadway died inside Stateville on a day inmates "reported excessive heat and poor ventilation," according to attorneys representing those incarcerated in the nearly 100-year-old prison. And late last month, those attorneys filed a motion asking Wood to intervene in the efforts to move the inmates.

"Right now, there's over 420 residents at Stateville who are at risk of dire injury due to the structural vulnerabilities, degradation and deterioration of those buildings that put them at risk of serious physical injury or even death," attorney Heather Lewis Donnell of Chicago-based firm Loevy & Loevy said at a news conference announcing the motion last month.

"We also know that every condition at Stateville – the water, the excessive temperatures, heat and cold, the vermin, the birds – are all exacerbated and compounded when the structure is not secure and when it is vulnerable," she added

In her order, Wood agreed to the motion and noted that IDOC officials "do not dispute that those who are incarcerated at Stateville face a risk of harm from falling concrete as a result of the deteriorated masonry walls, ceilings, steel beams, and window lintels" in the prison's general housing units.

Those conditions, she wrote in her order, "will remain unrepaired for the foreseeable

future because the State has determined that its resources would be better spent on building a new facility rather than attempting to repair Stateville's outdated facilities." The order does not apply to the roughly two-dozen residents of the facility's medical ward.

The state budget for the fiscal year that began July 1 included \$900 million for the plan to close and rebuild Stateville and Logan.

In an emailed statement, IDOC spokesperson Naomi Puzzello reiterated that prison officials would not begin to wind down operations at Stateville until at least mid-September. Though IDOC has not yet provided details on the plan to transfer the roughly 550 men currently incarcerated at Stateville, Puzzello noted the department's "anticipated timeline for transfers is in line with the order issued by the court."

Pritzker's plans to demolish and rebuild Stateville and Logan are hotly contested by AFSCME Council 31, the state's largest public employee union, which represents most prison workers in Illinois. In a series of public hearings on the proposed closures this spring, AFSCME members and community leaders objected to IDOC's blueprint – particularly balking at the lack of details in the administration's plans.

After a state oversight panel skipped an advisory vote on the prison closure plans in June, Pritzker indicated more specific plans would be made public in the future, though that still hasn't happened.

It's still unknown whether Logan Correctional Center will be rebuilt on its current grounds in Lincoln, or if, as the governor has floated, it will ultimately move 141 miles northeast to Stateville's campus in Crest Hill near Joliet.

Either way, IDOC officials say Logan will remain open as long as possible during the roughly three years it will take to rebuild the facility, no matter where that may be.

But any efforts on AFSCME's part to slow to Stateville's closure are now weakened by the judge's order with just seven weeks until Sept. 30. Still, the union indicated it wasn't done fighting the plan.

"The closure of Stateville would cause immense disruption to the state prison system, its employees, individuals in custody and their families," AFSCME Council 31 said in a statement. "We are examining all options to prevent that disruption in response to this precipitous ruling." □

Allow me to present a recommendation here, although the initial idea was relayed to me by my mother at a kitchen conversation 45 years ago when she served as a police and fire commissioner for the Village of Wilmette in suburban Chicago.

Part of the vetting process that
Wilmette police candidates submitted
to back in the day was an interview with
certified psychologists to help determine if
they possessed a proper temperament for such
a crucial job. Candidates could fail to make
the cut after the psychological screening for a
variety of reasons: displaying a short temper,
a significant lack of empathy, a tendency
to escalate tense situations, etc. I don't know
exactly how these psychological evaluations
were administered, but I do believe they
worked, and most citizens would welcome their
widespread adoption today.

Perhaps some larger area police

departments already employ such testing; small departments undoubtedly don't have funding for such efforts. Could a regional panel of psychologists be made available to central Illinois law enforcement agencies (with each contributing something to the cost)? Perhaps the state of Illinois could offer this service to the numerous agencies.

Policing is a vital and difficult job. There are many, many good cops serving the public with distinction. Most police officers are decent people. I'm grateful for their service. It's the few bad apples that need to be weeded out from the beginning. Psychological testing as part of the vetting process could help identify both quality and questionable candidates.

Allow me to end by offering sincere condolences to the Massey family; the unprovoked and senseless killing of Sonya Massey has left an indelible stain on our city. Let's enact some significant changes in her memory.

Battling blight

"At some point, studies need to translate into real action"

When Rosalind Bond finishes her work day and goes home, she is unable to enjoy the outdoors in her neighborhood on Springfield's east side.

The two-story house next door to her neatly kept ranch-style home in the 1400 block of East Jackson Street has been abandoned for more than five years and, to put it mildly, in disrepair.

The roof and siding are decaying. Weeds, trees and other foliage on the vacant property have grown so high that most of the front of the house is obscured. Holes in the structure, as well as a back door that remains cracked open, have welcomed stray cats, raccoons, opossums, at least one groundhog, and possibly some human visitors from time to time.

After living in her home for 26 years, Bond, 74, innovation coordinator for the nonprofit Springfield Project, said she is scared to go outside for fear of having to deal with critters scampering in and out next door. She even avoids her backyard because the foliage on the neighboring building darkens her own backyard during the day.

She also doesn't want any interactions with people who use the alley to regularly dump bags of household garbage in the vacant house's backyard.

"When I go in the house, I stay in the house," Bond said. "I've lived with this long enough. This is just ridiculous."

After years of administrative and court proceedings initiated by the city, the decrepit building is on the city's demolition list and could be torn down this fall. But the situation is emblematic of problems that Bond and other residents of the city's older neighborhoods have faced for years.

Deteriorating properties, abandoned homes and fly dumping in residential neighborhoods are long-standing issues in Springfield and have been the focus of a "working group" from the City Council consisting of three of the council's elected ward representatives.

The group, which was formed last year and met numerous times this year, discussed all of those issues and more. Little has emerged thus far when it comes to potential ordinances or firm policy recommendations, though the alderpersons say several initiatives are in the works.

"I want to make sure we have the best information before we start asking for changes," Ward 8 Ald. Erin Conley, a member of the working group, told *Illinois Times*.

"This is taking longer than I would have hoped for," she said. But getting council members and the public engaged in an issue ahead of time is "how you get a reasonable ordinance passed," she said, "and that's how

you get something that can actively improve the quality of life."

Landlord registration and rental inspections

Two of the major solutions pushed for years by the Springfield Independent Coalition for Our Neighborhoods (ICON) were a comprehensive landlord registration and inspection program for rental properties and reforms to the city's garbage collection system so all residents are billed for garbage service through their City Water, Light and Power bills instead of by individual waste haulers.

The lack of movement in the direction of these options in the city under former mayor Jim Langfelder and now current Mayor Misty Buscher, who took office in May 2023, is disappointing, according to the leader of ICON, a nonprofit that advocates for all neighborhoods and especially older sections of Springfield.

"If we are serious about the quality of life in Springfield and making sure that every neighborhood in the city is safe, clean and livable, then it needs to be a top priority of the mayor and City Council, involving systemic changes and process improvements and funding commitments," said ICON President Mark Mahoney.

Mahoney, who served as director of the Springfield Department of Public Works under former mayors J. Michael Houston and Jim Langfelder, said ICON is frustrated that more progress hasn't been made on landlord registration and a "comprehensive, user-friendly system" for garbage collection.

"Most of these initiatives are not new, and the mayor and council should be well-prepared and ready to move forward," Mahoney said. "At some point, studies, working groups, etc., need to translate into real action. A year is time enough for that to have happened if it was a true priority."

Buscher said her administration is making progress to improve the city's housing stock and in June launched an online "cited properties dashboard" that a news release said is "designed to provide transparency and facilitate a better understanding of property violations in Springfield."

Buscher said in the release: "We believe this tool will empower our community by providing them with valuable information about property conditions in their neighborhoods. Our goal is to create a collaborative effort in maintaining and improving our city's housing standards."

Mahoney said the database is "great, but it doesn't get to the root of the problems."

Buscher, whose husband is part-owner of The Real Estate Group, one of the largest real estate agencies in Springfield, isn't a fan of a proposed landlord registration program and said registration won't necessarily lead to action by landlords to improve and maintain their properties.

Mahoney believes it's unlikely there will be enough votes among the 10 alderpersons to enact major changes without Buscher's leadership, since most supported her candidacy when she denied Langfelder's bid for a third four-year term.

"The mayor has a pretty good lock on many of them," he said. "We have a small-town mentality as a community, but we are a city."

Many Illinois communities comparable in size to Springfield, including Bloomington, Peoria and Joliet, have systems in which landlords are required to register with the city, Mahoney said.

Registration promotes ease of communication when there are code violations or other problems, and he said registration is paired with regular inspections to spot problems early, when they are less expensive to fix.

The director of a landlord registration program in Bloomington, who later operated Joliet's program, spoke to ICON and Springfield Public Works Director Dave Fuchs about those communities' programs in the spring.

Fuchs said no one on the City Council is satisfied with the way the housing code is enforced in Springfield, and everyone wants to make the process more rigorous.

If Springfield adopted a program similar to Bloomington or Joliet, Springfield would have

to spend more or reallocate from other areas of city spending to expand inspections, he said. The current code enforcement system is driven by complaints.

Conley said a good compromise might be for the council to require that all rental properties register with the city the contact information of a person with the power to make improvements. But she hasn't ruled out broader action.

"The next step is to really bring a broader discussion to the (council) and drill down to what areas we want to address next," she said. "Let's look at things that work in other communities."

Conley said she would like Public Works officials to outline for the council the challenges with expanding rental property inspections. Conley, who works a full-time job with the state, said she hasn't had a chance to talk with Public Works about making such a presentation.

Ward 2 Ald. Shawn Gregory, a member of the working group whose ward covers much of the east side and part of downtown, isn't currently in favor of requiring all landlords to register but said he is willing to listen to any proposal.

"Anything that will push us forward, I'm open to it," he said.

When the cited properties database launched, almost half of the complaints lodged by the city

were against properties in Ward 2, which has many of the city's lowest-income neighborhoods. Gregory said the database helps him make the case about "how drastic our needs are.

"There's a sense in our community of, 'We're tired of looking at this. We want these things fixed," Gregory said.

In the coming months, he said he plans to introduce an ordinance that would create a program to financially assist responsible developers who would purchase some of the properties that the city has acquired on the east side to build or rehabilitate homes.

And Gregory said he plans to introduce an ordinance in coming weeks that would create a "reparations commission" made up of Black leaders and other Black residents.

Gregory, who is Black, said the commission would be similar to a panel operating at the state level and in Evanston and would recommend budget priorities for the council to assist residents of mostly Black neighborhoods whose families have been economically disadvantaged by the legacy of slavery in the United States.

"It should be a repair of everything that has been done," he said. "The key is investments in people."

Reparations could take the form of cash payments to residents and economic incentives, he said. "This is something I think we're missing in this city – a group to really look at the Black struggle and how we get it better in Springfield," Gregory said. "We have a lot of groups doing fantastic work and concentrating on some fantastic projects. And I just think it's time for us to give priority to a much-needed problem that's been studied and that we've talked about. I'm just to the point where I'm tired of talking, and I want to see some action done and some concrete things."

Garbage collection

Mahoney said the city would experience less fly dumping, such as what Gregory has seen in his ward, if everyone contracted with a waste hauler for garbage collection, as is currently required in city ordinance.

ICON believes the easiest way to enforce this requirement would be to put the fees residents and landlords pay for garbage collection on their regular CWLP bills.

Many Illinois cities, including Rockford, Bloomington, Normal and Peoria, either pick up garbage as part of city services or contract with a single waste hauler and collect fees for the service through water bills, general revenues or property

Lake Area Disposal Service Inc., a locally owned company and one of two companies picking up residential garbage in Springfield, has resisted proposals to allow the city to collect garbage hauling fees on behalf of Lake Area and the other hauler, publicly traded Republic Services

A sales manager for Lake Area has said such a collection method would make it easier for the city to contract with one hauler, a situation that Lake Area fears could put the 92-year-old company out of business.

Mahoney said the city also should consider requiring any waste haulers to pick up large items to make the process more user-friendly rather than contracting with a nonprofit, Habitat for Humanity, for large-item pickup.

Conley said she is waiting for responses from CWLP officials and Greg Moredock, the city's chief legal counsel, for information on the challenges of enacting major changes in garbage collection.

"I want the easiest solution to be the solution," she said. "I want to know what will work. ... We've had a lot going on in the city. ... We're dealing with a city that was chronically understaffed for a long time."

Gregory said he would like to see Public Works add a second crew to collect garbage that is dumped in yards, along roads and in ditches. That option was discussed by the council but didn't make it into the current fiscal year budget.

Ward 5 Ald. Lakeisha Purchase, who serves on the working group with Conley and Gregory, said discussion in the group resulted in a proposal to create a form that would be filled out by tenants and landlords, then given to city officials so the city knows who is responsible for paying for garbage pickup and it's easier to identify violators.

The group will continue to meet, Purchase

On the issue of garbage collection, Buscher said she is open to reforms but, as she said for an *Illinois Times* story in April, she has been too busy with other issues – such as hiring more people for understaffed agencies – to turn her attention to garbage just yet.

"I've been mayor 15 months now, and I can't fix every problem in a broad-brush stroke overnight," she said. "Issues are prioritized, and we're doing the big, heavy lifts first."

Blighted properties

When Gregory looked at the dilapidated building next to his constituent's home on East Jackson Street, he said, "One house like this hurts the whole dang block."

Legal hurdles to tear down such structures can take several years, Moredock said. That's because he said city ordinances and state law require legal notice to lien holders and the property owner, and sometimes heirs in the case of a death.

There are also legally mandated waiting periods for responses and appeals before the city can demolish private property, he said.

The process can take even longer if the property owner continues to pay for utilities long after a property is vacant, Moredock said.

The City Council has taken steps in recent years to reduce administrative delays under the city's control and has appropriated more money for demolitions, he said. City officials would prefer to create incentives for rehabbing

properties rather than creating more vacant lots, but some properties are beyond repair, he said.

The city in 2023 handled 725 cases in its administrative court dealing with housing-code violations. The city completed 44 potential demolition cases. And among those 44 cases, 10 houses were demolished by the city, 19 were demolished by property owners and the remaining 15 were repaired by their owners, Moredock said.

That same year, there were 127 pending demolition cases. Of those, 78 were awaiting demolition, and the remainder were awaiting further legal action, Moredock said.

The city is about to request bids for the demolition of 35 houses, Public Works Director Fuchs said.

"The amount spent and the number of houses demoed really depends, but I can say the average is about \$500,000 per year and about 35 houses, but this varies year by year and depends on the grants available," Fuchs said.

The houses being demolished for the rail relocation project "are entirely separate from this," he said.

"The basic problem is we've got a lot of dilapidated properties in the city of Springfield, and we're working our way down the list," Fuchs said.

Fuchs said the five zone managers who were hired this year by the Buscher administration, with each manager assigned to two wards, have assisted residents concerned about dilapidated properties, fly dumping and other neighborhood issues.

"They are available to listen to citizens' complaints," he said. "They are able to explain the various processes involved in all of these

complaints, and that seems to help."

By the time a property gets on the city's demolition list and the city seeks demolition contractors, Moredock said, "The neighbors have been annoyed with this property for years."

That's the case for the East Jackson house as well as for a dilapidated home mostly surrounded by overgrown trees and foliage in the 4000 block of Marie Drive in the Irisdale Subdivision on the city's northeast side.

Neighbors refer to the home, which has been vacant for more than a decade, as the "haunted house."

Victoria Edmison, 61, a retired city worker who lives next door and was one of Irisdale's original homeowners 30 years ago, said she tries to avoid looking at the abandoned property, which she referred to as "an uncontrollable mess"

She said she is confident the decaying, onestory building has reduced the value of the home she shares with her husband, Michael.

The city has arranged for grass on the property to be cut, but the foliage remains.

Edmison said she was glad to learn from *Illinois Times* that the house likely will be torn down by the end of the year.

"It's just been hard to be happy here," she said. Ward 3 Ald. Roy Williams Jr., in whose ward the Marie Drive property sits, said he's frustrated that it takes so long to tear down these types of properties.

"It shouldn't take 10 years," he said. "It's a flaw in our system." \square



Savory galettes

Combine corn, summer squash and goat cheese to make rustic, lazy man's pie

I've been spending my summer as a chef at Prairie Fruits Farm and Creamery in Champaign. I consider myself to be in pretty good shape, but by the end of my workweek, my 71-year-old butt is dragging! When I drive back home to Springfield after my last shift, I count on my two days off to rest up for the next week. The last thing I want to do is spend my recuperation time fussing in the kitchen.

However, my days off also are times to catch up with family and friends so on most weekends we have people over for wine and nibbles on our front porch. I try to keep the menu simple and usually bring back goat cheese from Prairie Fruits, but on a recent weekend, I came home to a glut of sweet corn generously gifted to us by farmer friends. We also had an abundance of summer squash, so I needed to develop a quick, easy dish utilizing goat cheese, corn and squash. My solution was a savory galette.

Galettes are essentially a rustic, lazy man's pie. They can be sweet or savory. Galette crusts are shaped free-form on a sheet pan rather than baked in a pie pan. While a traditional pie crust is pressed into the bottom and sides of a pie pan and decoratively crimped along the edges, a galette crust is rolled out flat, topped with filling, and then folded over onto itself in a round shape. No one wants to turn on the oven in hot weather, but a galette bakes for only 30 minutes. So at least the oven won't be on for long. The galette dough benefits from chilling in the refrigerator. It can be made a day before.

Savory galettes are blank canvases. The filling can be made with tomatoes, onions, peppers, eggplant, summer squash, corn, potatoes, mushrooms or even braising greens such as kale or collards. You are only limited by what's available and your imagination. The only requirement is that the filling components are precooked. Because of the relatively short baking time, raw vegetables may not cook fully or evenly. Many vegetables have a high water content, and precooking will release much of the liquid, preventing a soggy crust. Savory galettes are a good way to use up leftover cooked vegetables. You need about three cups' worth

This galette uses a basic pie dough that bakes into a flaky crust. All that's needed is flour, butter, water and a little salt and pepper. It comes together so easily that I don't bother dirtying a food processor. I just use my hands. You need to avoid overmixing. If you overmix, the gluten in the flour will begin to develop, which results in a tough crust. When making

this dough, the colder the ingredients, the better. I put my butter in the freezer well ahead of time so it's frozen solid. With cold butter, your pie crust will be light and flaky, because as the cold butter melts in the oven, it produces steam that creates flaky layers.

Corn, summer squash and goat cheese galette

Serves 6-8

Ingredients:

For the dough:

1 ¼ cups all-purpose flour, plus more for dusting

34 teaspoon kosher salt

34 teaspoon freshly ground black pepper

1 stick butter- frozen

Ice water

1 egg, beaten (for egg wash)

For the filling:

1 tablespoon neutral cooking oil

1 medium shallot, minced

 $1\,$ medium summer squash or zucchini, sliced into $1\!\!/\!\!4$ -inch rounds

½ teaspoon kosher salt, more if needed

1/4 teaspoon freshly ground black pepper

2 tablespoons unsalted butter

2 cups fresh corn kernels, cut from 3-4 ears of

1 tablespoon fresh thyme leaves or 1 teaspoon dry thyme

2 tablespoons Dijon mustard

8 ounces fresh goat cheese, room temperature

Preparation

Make the dough:

Well ahead of time, place a medium mixing

bowl, box grater, and butter in your freezer to thoroughly chill.

When ready to make the dough, prepare some ice water. Combine the flour, salt and pepper in the chilled mixing bowl. Grate the frozen butter directly into the flour mixture through the large holes of the chilled box grater. Dipping your stick of butter into some extra flour will make it easier to grate.

With your hands, gently toss the grated butter in the flour until combined. The cold butter should end up the size of peas. Drizzle ½ cup ice water into the mixture, stirring until the flour is evenly moistened. With your hands, gather the dough into a ball, transfer it to a floured work surface, and knead gently until it comes together. If the dough starts feeling warmer or the butter is melting, put it back in the fridge for 10 minutes to chill. Do not overwork. Form into a disc, wrap in plastic, and refrigerate for at least one hour or overnight.

Make the filling:

Heat a large sauté pan over medium heat and add the oil. When shimmering, add the squash slices, season with half the salt and pepper, and cook, turning once, until the squash gives off some of its liquid and starts to soften – about four minutes. Transfer to a plate and set aside.

In the same pan, melt two tablespoons butter, stirring continuously. Add the shallots. After the butter foams and sizzles around the perimeter of the pan and turns golden brown, add the corn kernels, thyme and the rest of the salt and pepper, and continue stirring until the corn is hot, but not mushy. Remove from the heat.

Prepare the galette crust:

Preheat the oven to 450 degrees. With a rolling pin on a lightly floured work surface, quickly roll the cold dough into a 14-inch circle. Carefully transfer to a baking sheet lined with parchment paper. Leaving a 1½-inch border, spread the Dijon mustard over the dough with the back of a spoon. Distribute the goat cheese evenly over the mustard, then top with the corn mixture. Level the corn with a spatula. Starting at the perimeter, arrange the squash slices in an inward spiral, overlapping slightly.

Fold the dough edges up over the vegetables to create a 1 ½-inch border. Brush the dough border with egg wash.

Bake the galette until the crust is golden brown, about 30 minutes.

Allow to cool. When ready to serve, cut into six or eight wedges. \Box

As we enter the waning days of the Illinois State Fair, the weather, which arguably has more to do with the fair's success than anything else, has cooperated quite fabulously and allowed for super-duper attendance figures. And if not recordbreaking numbers (but maybe), those attending the fair thus far found recordbreaking comfort in the mild temps. Let's spend a bit more time out on the grounds, then ramble 'round the town to see what else is going on.

One definite benefit to area musicians from the fair effect comes from exposure (yes, people die from exposure, but that's a musician joke) to a variable number of listeners and also from payment through the (fairly) decently compensated performances. Most musicians say the worst part about a fair gig is getting through the gates (even with tickets and parking passes) and driving through the crowded streets to the various stages, then setting up and tearing down on a tight schedule. The best part is always playing the music (they don't call it working the music) with the money earned a close

Here are a few random local groups I recognize playing around the fair. On the Apex Stage (near the Grandstand) there's The Tangents (Thursday at 2 p.m.), Astrofix (Friday at 4) and Dos Okies (Saturday at 3:30,) plus another nine acts also on the bill. Springfield fans of Bloomington's acclaimed singer-songwriter Dan Hubbard will be pleased to know he's scheduled at the Illinois Wine Experience in the Artisans Building on Saturday, 4 to 7. The Expo Building Stage has tons of acoustic acts, including shows by area folks Stuart Smith (Thursday at 4), Tom Beverly and Geoff Ryan (Friday at 6) while Saturday has Beige Desperados at 2 and the Pepper Sprouts at 4, with Myers-Brant-Paoni closing it out on Sunday at 5, along with another seven some acts there, too.

From what I hear, the Grand Central Stage in the Reisch Pavilion is the big hit this year with a combination of touring bands called "spotlight artists" and other groups. This Friday is a good example with Illinois-based combo BoomBox 80s Band doing all 80s pop/rock at noon, Springfield's own Johnny Cash tribute band, Folsom Prison Five, at 3, the "spotlight artist" act, Vandoliers, from the Dallas-Fort Worth area playing all original, alt-country songs at 7, followed by our long-running, much appreciated, Harris family band, Bustin' Loose, at 9. With that I bid "fair-well" to the

fair for 2024. Check the daily listings on the ISF website for what's left through Sunday.

Outside the long arm of the fair, most of our regular scheduled programming of music continues unabated along with a few special events set to compliment or counter fair business, depending on how you perceive the situation. Most prominent is the Curve Inn's SouthSide Fair happening concurrently with the State Fair and featuring mostly acts that aren't playing at the ISF-sponsored beer tents.

Thursday it's a classic country combo of White Lightnin' and Bustin' Loose. Friday features the fantastic Kapital Sound and Saturday brings Chicago's Real Pretenders showcasing our very own Andon Davis on guitar with openers JackAsh. Sunday is a special day celebrating Rick Mari's 70th birthday with a bash featuring The Rick Mari Band. Rick's contribution to our scene is decades long and still going strong, so head out to support him and ask about the bands he's been part of for the last 50-some years.

Don't forget to vote in our nominating round for Best of Springfield before it ends at 11:59 p.m., Monday, Aug. 19. See you next week. □
